Constructive and expeditious review process of high quality

The journal editors are interested in challenging, interdisciplinary studies from diverse areas of service research. The review process uses double-blind reviews with at least two reviewers. Members of the editorial board as well as outstanding colleagues will be consulted for the review process. The editors promise to make a binding decision on acceptance or rejection after a maximum of two rounds of review. The review process leading to an initial decision takes a maximum of 60 days. In addition, emphasis is placed on constructive reviews that are likely to effectively improve the quality of manuscripts.

Rapid publication

Once a manuscript has been accepted by the editors, publication takes place within six months.

Ethical principles of publication

In accordance with the mission statement of the publishing houses Nomos and Vahlen, the Journal of Service Management Research SMR aims with its scientific publications to promote and disseminate understanding and knowledge in the research field of service management. In line with this mission statement, the journal takes a neutral position on the topics discussed in its articles.

We make the journal's contributions available in the following forms:

- as a printed edition (subscription)
- in the digital archive of the Nomos eLibrary with search functions and a download in PDF format
- via EBSCO with a lock of 12 months
- via JSTOR with a sliding threshold of 3 years
- as online acquisition of individual articles (in the planning stage)
- as open access for selected articles

The *Journal of Service Management Research (SMR)* is committed to ethical standards at all stages of the publication process. We also recommend the Committee on Publication Ethics' (COPE) <u>Best Practice Guidelines</u>.

Ethical principles of publication for the editorial board

Editors are responsible for all publications in the journal. Therefore, measures are required to review the quality of articles accepted for the journal and a willingness to publish clarifying and corrective statements when necessary. Editors are required to fulfill their obligations in a fair and balanced manner without discrimination based on gender, ethnicity, sexual orientation, or religious or political beliefs. They shall carefully inform authors, as well as reviewers, of any expectations placed upon them.

Peer-Review

The editors should be able to decide independently of the publishers publishing the journal which articles will be published in the journal based on their quality and suitability for the content.

They shall process submitted articles in a timely, fair, and unbiased manner; they shall treat all manuscripts confidentially and submit them to others only for the purpose of peer review.

Editors-in-Chief use security measures to keep the identity of peer reviewers confidential, unless an open peer review system is used, which is communicated to both authors and reviewers beforehand.

The *Journal of Service Management Research (SMR)* assures that decisions related to the publication of the journal are not influenced by economic interests. None of the individual issues may be financed by third parties. In addition to its own ethics policy, editors are guided by the <u>COPE flowcharts</u> in the event of suspected misconduct (including plagiarism cases) or disputed authorship.

To appeal actions taken by the Editors-in-Chief, authors of the *Journal of Service Management Research (SMR)* may contact any of the editors. Such action is expressly provided for as a procedure by the publishers.

Editors-in-Chief

The Editors-in-Chief provide guidelines to new members of the Editorial Board on all requirements affecting them and update existing members on new regulations and developments.

Conflicts of interest

If the Editors-in-Chief are themselves affected by a conflict of interest, they ask a member of the Editorial Board to edit the submission in question. Similarly, they handle conflicts of interest among collaborators, authors, reviewers, and editorial board members.

Ethical obligations of authors

Authors must make a declaration that the content of the manuscript submitted was developed by themselves, or provide appropriate evidence for content taken from other sources, in order to avoid accusations of plagiarism. They must assure that their contribution does not contain any defamatory or defamatory elements and does not violate any copyrights, other rights affecting intellectual property or other rights of third parties.

The order in the author citation should be determined jointly by all participating authors and should accurately reflect who wrote the article and conducted the research on which it is based. All participating authors must be aware of the submission of the article for publication in the journal and give their consent for the lead author to contractually agree to the transfer of copyright on their behalf.

Authors warrant that the manuscript in question has not already been submitted for publication elsewhere, is under review, or has already been accepted. If any part of the manuscript agrees with a work already published or submitted for publication, this must be stated and substantiated accordingly.

Authors must obtain appropriate permission to reproduce any content from other sources (text and images). The Journal of Service Management Research SMR regrets that it is unable to publish content from third parties unless permission has been obtained (except for content covered by fair dealing).

All research papers produced with the help of a grant must acknowledge the source of the research project's funding. Any other support should also be clearly identified in the paper, typically in an acknowledgement. In addition, authors should declare any potential conflict of interest related to an article. If a significant error is found in a previously published article, authors should inform the editors and publish a correction, an amendment, or, if necessary, a retraction together with the editors.

Ethical obligations for peer review of journal articles

The review of a manuscript shall be conducted with care, deliberation, and objectivity in as timely a manner as possible and shall help improve the quality of a submitted article.

Reviewers must notify the journal editors if they know of a publication or an article submitted for publication that is similar in content to the reviewed manuscript, or if plagiarism is otherwise suspected. They must make it clear if a possible conflict of interest arises with regard to a particular article or author; in doing so, the confidentiality of any information and material that plays a role in the review process must be maintained.
