

Editorial notes for authors of the journal Gesundheits- und Sozialpolitik

Dear authors,

If you would like to publish an article in the journal 'Gesundheits- und Sozialpolitik' (Health and Social Policy; following GuS), please take note of the following information before preparing and submitting your manuscript. If you have any questions, please do not hesitate to contact the editorial office.

Topics/Contents

'Gesundheits- und Sozialpolitik' has been published by NOMOS for over 76 years. As an independent journal, it reports on new developments in legislation and management of the healthcare and social security systems. Experts, insiders and academics discuss current reforms, prepare background information, draft scenarios for the further development of the healthcare system, outline shortcomings, describe forms of and conflicts in management, and document case law in a condensed form. 'Health and Social Policy' is aimed at companies in all sectors of the economy—especially those in the health and social sectors—at associations, human resources managers, administrative departments, trade unions, works councils and academics in the fields of health and social policy. Length

Your article should preferably consist of 30,000 to 35,000 characters (including spaces). If the length of your article differs considerably from this character count, please contact the editor in advance. Please send your manuscript to the GuS email address provided above.

Abstract

Please prepare a short abstract for your contribution, which should not exceed 5–8 lines. The text can either contain the article's core message and/or its clearly defined basic hypothesis or a summary of the article.

Your information

Please submit a short description of your current professional position and, if applicable, those of your co-authors (title, current professional position, institution, location).

Body text

Please write your article's main body as continuous text without page breaks or page numbers in font size 12, font type Arial, with 1½ line-spacing, left-aligned and without hyphenation. If possible, your manuscript should be written using a current version of Microsoft Word. In order to ensure that the production process is as smooth as possible, it is important that you only submit a final version of the manuscript, approved of by your co-authors if necessary, and the figures or tables it contains. It is generally not possible to make adjustments to a manuscript's content in the course of the proofreading process. Please insert the footnotes as endnotes at the end of the text. Please note that too many footnotes make the text difficult to read.

Structure

Please structure the text as hierarchically as possible with continuous Arabic numbering. Any subsections should have a maximum of three digits (e.g. 1.1; 1.1.1; 1.2). However, you have some leeway with regard to your structure. You can, for example, dispense with numbering altogether.

Figures and tables

If you use figures and tables, please use Arabic digits to number them. Please provide a heading (in bold) for each figure or table and—most importantly—a reference to the source as well as a frame (line width ½, black, not dashed and not "automatic"). Please use font size 10 for figures and tables. Please provide your

figures and tables as a single file. Please indicate in the text the ideal position for the figures or tables. The figures should be submitted in one of the following formats: TIFF, GIF, JPEG, EPS, PICT, BMP, PSD; their resolution should be at least 300 dpi—their width at least 12 cm. The same applies to Excel tables and diagrams. Please also send them as PDF files. Important: The number of illustrations and tables should be in proportion to the length of the text. Too many figures and tables will make it difficult or impossible to design a sensible layout for the article.

Colour

Figures are usually printed in black and white and should therefore be submitted in greyscale. Please ensure that graphic elements are not filled with gridded areas, but at most with a complete surface, i.e. a smooth structure. Please note that the journal's layout will differ considerably from the layout of your computer printout. Therefore, please only use illustrations and tables that are absolutely necessary for the content of your article. You can work with original files of the programmes Microsoft Excel or Microsoft PowerPoint on Windows. In any case, please include reproducible printouts.

Corrections

After typesetting, your article will be returned to you at short notice for correction. Corrections should be made as soon as possible. When correcting, please ensure that the corrections are readable and comprehensible. A corrected Word version of the text is not acceptable. Before the editors approve your manuscript for printing, you will receive your contribution again for your final check and approval. Extensive corrections are generally no longer possible at this stage. At most, minor errors can still be corrected. Please note: The article will not be "proofread" by the editors. At most, you will receive minor suggestions for editorial changes. If necessary, minor errors will be corrected by the editors, but they will not systematically check spelling, comma placement, etc. This is the sole responsibility of the authors.

Checking the content

As a rule, each contribution submitted is checked for its technical accuracy, quality, etc. by the editorial staff, the publisher and, if necessary, independent experts. As a matter of principle, contributions that have been produced by agencies and/or that clearly serve advertising purposes will be rejected.

Authors' copies

The authors or authors' associations receive complimentary copies of their work from Nomos. For this purpose, the editors require an address to which Nomos can send the authors' copies, if possible, at the time the article is approved for printing. You will receive a form from the publisher for the necessary information.
