



Guidelines for the Submission of Manuscripts (July 2024)

I. Manuscript submission

Manuscripts on topics of European and international law are to be submitted to the following address: zeus@europainstitut.de. Since 2024, all articles in ZEUS are published both in print and *open access* in the [Nomos eLibrary](#).

ZEUS does not restrict the length of manuscripts, provided that the text is concise and to the point. Shortening may be suggested during the review process. Manuscripts submitted to ZEUS should not have been previously published and should not be under review of another journal at the time of submission.

Manuscripts submitted to ZEUS should include an **abstract** (max. 200 words) and 5-10 **keywords**. The abstract and keywords should precede the main text. Author details should be given in an **asterisk footnote** (title, current position, university/institution with country, email).

Authors agree to transfer the following rights with respect to their work to Nomos publishing house for the duration of the legal copyright: the exclusive, worldwide and temporally unrestricted right to reproduce and distribute in physical form; the right to public reproduction and display; the right to inclusion in databases; the right to store on electronic data storage media; the right to distribute and reproduce such storage media; and the right to make other use of the work in electronic form. This final right includes the use of electronic forms that are, at present, unknown. This granting of rights also covers the exploitation of the rights of use both by the Publisher itself as well as through the transfer or the granting (including partially) of rights to third parties.

II Formatting

Manuscripts are to be submitted as a Word document with footnotes. The **bibliography** is listed at the end of the document.

III Text

Structure: A. - I. - 1. - a) - 1) - aa)

No table of contents is inserted at the beginning of the article at the time of submission.

Abbreviations should only be used sparingly in the text, e.g. for court names (ICJ, ECJ, ECtHR, etc.). Abbreviations are written out in full the first time they are mentioned.

Headings should not be formatted

Emphasis in the text by italics only.

Quotations in continuous text are to be marked with inverted commas – without italics.

IV. Citation Guidelines

Example: *Calliess*, in: Callies/Ruffert (eds.), Art. 12 TFEU, para. 12
- **Articles:** *Author*, journal year/issue, pages
Example: *Giegerich*, ZEuS 2008/2, p. 35
- **Internet Sources:** *Author*, title, available at: URL (last access)
Example: *Giegerich*, Noch ist der Rechtsstaat nicht verloren, available at: https://jean-monnet-saar.eu/?page_id=2222 (8/7/2024) [blog posts and newspaper articles are generally only listed in the footnotes and not in the bibliography]

→ Other internet sources should only be used sparingly. In this case, the exact URL and the last access date are specified. Example: <https://www.nomos-elibrary.de/zeitschrift/1435-439X> (23/7/2024)
- **Official Journal:** OJ L XY of date DD.MM.YYYY, page

V. Bibliography

Every author cited in the article must also be included in the bibliography (exception: blog entries, newspaper articles and other internet sources). Authors should be listed in alphabetical order. In case of several works by one author, the most recent work is listed first. If several authors are involved in the same work, their names are separated by a semicolon.

Monographs: SURNAME, NAME, *title*, edition, place of publication, year of publication

Collective Volume: SURNAME, NAME, *title*, in: Surname editor, name editor (ed.), *title*, edition, place of publication, year of publication, pages
